Effects of Overexposure

Inhalation of vapors may cause coughing, chest pains, or nose and throat irritation. Inhalation of vapors may cause coughing, chest pains, nausea and vomiting. Liquid may be irritating to skin, eyes, and mucous membranes. Liquid may cause dermatitis. Ingestion may cause nausea, vomiting headaches, dizziness, gastrointestinal irritation. Steps to be taken in the event of a spill or discharge

Take up with sand or other non-combustible absorbent material and place into container for later disposal. Flush area with water.
